Privacy Policy

Thank you for visiting our website. Your privacy rights are especially important to SolidTude ("we" "our," "us"). Types of Information Collected

Use of Tracking Methods

Cookies

We may collect information using "cookie" technology. Cookies are small text files that a website stores on your computer or mobile device's hard drive to recall and store information about your visit. We may use "session cookies" that expire when you close your web browser or "persistent cookies," which stay on your computer for a specified amount of time or until you

delete them. Cookies help us enhance our website and its features. You may turn off the cookie feature in the browser of your computer or mobile device. Note, that doing so may affect your experience with our website.

Web Beacons

We may use web beacons or "clear gifs" that collect limited information such as a cookie number, time and date of a page view, and page description. How Your Information Stored

We retain the information you provide for the duration of our relationship plus a reasonable period or until the end of the applicable statute of limitation period mandated by law. If you wish to receive marketing communications, we will keep the information necessary to send you these communications until you contact us to opt out of these communications.

We use commercially reasonable methods to secure the information you provide to us and the information we collect automatically. This includes using standard security protocols and working with reputable third-party vendors.

We may use software programs to create aggregate statistics to assess: (1) the number of visitors to the different sections of our site; (2) which content is of most and least interest; (3) web design; and (4) system performance. For website security and to provide service stability, we may use software programs to monitor network traffic to identify and thwart unauthorized attempts to gain access to our network.

Choices with Your Information
